Health products: Odour reduction performance



- Odour in the products can result due to different materials used (adhesive, polymer, coating...) and can be unpleasant when used frequently as is the case for surgical masks.
- The industry is constantly researching and developing innovations to reduce, neutralise malodour emitted from it.
- Synthetic odorant mixtures aimed at reproducing the use of the products as closely as possible to reality and sensory analysis (olfactometric test) to evaluate the product efficacy in reducing the malodour could help manufacturers evaluate their products and technologies for a strong justification of odour control claims
